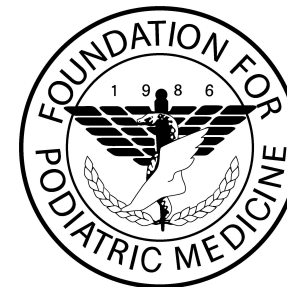

Bryan C. Markinson, DPM graduated from the New York College of Podiatric Medicine in 1981. He served as a Fellow from September 1993 to June 1995 in the department of Dermatopathology at the University of Medicine and Dentistry in New Jersey, under the direction of W. Clark Lambert, MD, PhD. Shortly thereafter, Dr. Markinson founded the Podiatric Pathology service at the Mount Sinai School of Medicine.

Bryan is currently Associate Professor and Chief of Podiatric Medicine and Surgery in the Leni and Peter W. May Dept. of Orthopedic Surgery of the Icahn School of Medicine at Mount Sinai in New York City. He is also an instructor in the Department of Dermatologic Surgery and Team Member of the Skin Cancer and Melanoma Unit of the Tisch Cancer Center.

He is a frequent lecturer nationally on various aspects of podiatric dermatology and nail pathology. In 2004, he was elected to the Board of Trustees of the Council for Nail Disorders, a position he still holds. He's certified by the American Board of Podiatric Medicine.

He is a 1973 Summa Cum Laude grad of Pennsylvania College of Podiatric Medicine and went on to residency at Monsignor Clement Kern Hospital in Warren, Michigan in 1975. He is currently in private practice in St. Louis, MO. He served as a residency director for 25 years and served as an editor to Journal of Foot Surgery, Podiatry Today, Foot and Ankle Quarterly and Clinics in Podiatric Medicine and Surgery.
